

## Financial Notice Modification of exclusion criteria within the extra-financial approach

The unit-holders of the Undertakings for Collective Investment ("UCIs") **AMUNDI ENHANCED ULTRA SHORT TERM BOND SELECT\***, the management company of which is Amundi Asset Management, are informed of the changes in the exclusion criteria implemented within its extra-financial approach.

Therefore, issuers with an Amundi ESG rating of «F» are no longer excluded from the portfolio.

These changes do not need to be approved by the *Autorité des Marchés Financiers* (AMF - French Financial Markets Authority).

The other characteristics of the funds will remain unchanged.

The regulatory documentation of AMUNDI ENHANCED ULTRA SHORT TERM BOND SELECT will be updated to reflect these changes from 31 January 2025.
